It is an honor and privilege to award you the Connecticut Association for Infant Mental Health (CT-AIMH) 2024 Jane C. Bourns Award for Excellence for Exemplary Service to Young Children and Families in the field of Infant, Early Childhood Mental Health. You have been a founder, leader, and guiding light for CT-AIMH since its inception. You served as a CT-AIMH Board member and President, a founding member of the Alliance for the Advancement of Infant Mental Health, and their Board President; and an inspiring leader and strong advocate for infant and early childhood mental health for over 40 years. We can't even imagine what this journey would have been like without your clear vision, your gentle strength, your warm collaborative way, your steadfast commitment, and your informed and wise guidance.

Already a respected leader in the Southeast Connecticut community, you were a natural for the initial leadership team. You were familiar with multiple sectors in the early childhood system, you knew the void created by limited infant mental health capacity within the professional community and services system, and you saw the potential a CT Association might have, reflective of the Michigan model, for infants and toddlers and their families as well as all those who partner with and support them.

You always had a welcoming approach to building the CT Association. You were a partner with leaders from various sectors in setting a 'birthing plan' and brought together a diverse group of practitioners and leaders for the very first CT-AIMH Reflective Supervision/ Consultation group. Because of the visibility of your success in the early days of the Association, when invited by the Children's Bureau to be in the first cohort of Early Childhood Child Welfare grantees, it was unquestionable that CT-AIMH would be a key partner and that the federal grant application would be based on the establishment of the 8-day DCF infant mental health training series and subsidized reflective supervision/consultation, both of which continue today and which opened the door for ongoing DCF funding.

You wrote many influential papers on topics such as: reflective practice, infant mental health practices, workforce development, CT-AIMH's work during COIVD, etc. You also presented at Zero to Three and World Congresses of the World Association for Infant Mental Health. Your scholarship and leadership extend beyond the borders of our state, reaching far and over many years through your notable leadership contributions to the Alliance for Infant Mental Health and the World Association.

In appreciation for your contributions to our children and families, our profession, and our local, state, national and world communities the CT Association of Infant Mental Health is establishing The Margaret Holmberg Scholarship Fund, beginning in 2025.
